This one day workshop is specifically designed for the building principal, internal coach, and external coach of school teams beginning the PBIS Tier 1/Universal training process. This day is focused on preparing Coaches and Administrators for the various activities and steps their teams will progress through as they implement PBIS in their schools. *Those attending this working day must also attend Tier 1 training with their designated school team.*

Tier 1/Universal Team Training (2 days) - August 27 & 30, 2012

To begin developing the knowledge, skills and materials needed for implementation, the school PBIS TEAM, including administrator and coaches, participate in these 2 intense, interactive and activity-based days. These are guided team work days to begin developing the materials needed for PBIS Kick-Off and implementation.

New Coaches Orientation and Preparation for Tier 1 Training

Thursday, August 23, 2012

8:30-3:30 (8:00 registration)

Held at: CESA #2 Conference Center

Content: Participants will gain an awareness of the philosophical foundation of PBIS, the role of coaches in the PBIS implementation process, the skills needed for effective coaching and the role of coaches in the use of data for decision-making. The discussion will include:

- Coaching competencies—your job as an internal coach
- Keeping track—getting your job done
- Efficient team meetings
- Evaluation for continuous improvement utilizing PBIS assessment tools

Who should participate: Internal Coaches at the Universal Level, External Coaches, Building Principals

What participants should bring: Artifacts relevant to school-wide implementation such as annual school calendar, available discipline data, school-wide acknowledgement systems, behavior teaching plans, school improvement plan.

Participants will: Network with other coaches and discuss perceived and realistic roles of coaching, review the PBIS coaching role, and become acquainted with PBIS assessment tools: The Team Implementation Checklist (TIC), the Self-Assessment Survey (SAS) and the School Profile Tool. Coaches will identify three strengths and three areas that need improvement in their school-wide plan based on their SAS report and create an ongoing action plan to be utilized with the universal team during Tier1/Universal Training.

Objectives:

1. Understand the basic rationale and features of School-wide Positive Behavior Support (SW-PBS)
2. Define the coaching roles, functions, outcomes and competencies
3. Understand system assessments
4. Gain an understanding of team roles and functions
5. Understand the importance of Tier 1/Universal training components

Developing Your Tier 1/Universal System

Day 1-Monday, August 27, 2012

8:30-3:30 (8:00 registration)

Held at: CESA #2, Whitewater



Content: Participants will learn the systems, data and practices imbedded in PBIS implementation. The team will draft school-wide Behavioral Expectations, create a Behavioral Matrix and plan for team development.

Who should participate: Building level Universal team that includes: Building administrator, external and internal coaches, regular education teachers that represent grade levels, special education teacher, social worker and/or psychologist, specials teacher, paraprofessional and family members.

Participants should bring:

- Forms and processes related to discipline policy and practices (District and/or School Discipline Handbook, office referral forms, Self Assessment Survey results, character education curriculum, etc)
- Discipline data
- Laptop for team use

Objectives:

Understand the essential components of school-wide positive support systems that provide behavior supports to all students

1. Review discipline data (Big Five graphs) and begin the process of data-based decision-making to meet student needs.
2. Review the impact of student behavior on academic outcomes
3. Discuss and plan school-wide practices and procedures that encourage students to engage in positive behavior and discourage problem behavior
4. Identify 3-5 school-wide behavioral expectations/rules
5. Begin to develop definitions of school-wide behavioral expectations by location (matrix)
6. Begin process of turning new behavioral expectations/rules into teachable lesson plans

Developing your Tier 1/Universal System

Day 2-Thursday, August 30, 2012

8:30-3:30 (8:00 registration)

Held at: CESA #2, Whitewater

Content: Participants will build on their work from Day 1 and will continue by developing an acknowledgement plan, developing a chart of office-managed versus classroom-managed behaviors, establishing procedures for a continuum of interventions, evaluating the efficiency of “working smarter” among school teams, and creating a system for effective meetings.

Who should participate: Same team members who attended Day 1

Participants should bring: Day 1 materials, forms, data and laptop

Objectives:

1. Finalize behavioral lesson plan(s) for teaching school-wide behavioral expectations
2. Teach a “Cool Tool/Behavioral Lesson Plan” to peers
3. Delineate school-wide procedures to acknowledge expected behaviors
4. Identify classroom-managed versus office-managed problem behaviors (T-chart of behavior)
5. Identify current data-based decision-making process and make necessary improvements in forms, flow charts and processes of addressing challenging behavior
6. Complete the “working smarter” activity
7. Establish effective team process (system, data and practices)
8. Action plan: Rate team checklist and develop next steps
